INTERIM APPROVED PRODUCT GUIDE

Beauty Without Cruelty is in the process of re-auditing all companies that appear on this list and many new products that claim to be “not tested on animals”.

HUMANE CRITERIA

- 1. Cut-off date:** Beauty Without Cruelty requires a self-imposed cut-off date (with regard to the use of animal tested ingredients) from applicant companies and neither products, nor the ingredients contained therein, may have been tested on animals after this date.
- 2. Ingredients:** Products may not contain substances, which have been obtained as a result of the suffering or death of an animal.
- 3. Assurances on Testing:** Written assurance must be obtained that the applicant company, as well as its own subsidiary companies, its parent company/ies and other subsidiary companies of the parent company/ies, have not commissioned any form of live animal testing, on individual ingredients, or

on any of their finished products after the cut-off date and furthermore, written assurances must be obtained that specific ingredients which are contained in the products, have not been so tested by the ingredients supply company since that date. Also, products may not contain ingredients that have been required by law to be tested on animals (or from animal test data) after the cut-off date.

- 4. Parent companies and their subsidiaries** (where applicable) must comply with the above criteria, as any company, whether acceptable on its own or not, will be contributing profits to the parent company, and its subsidiaries.
